## 01. Official ARC tariff and appliance list for SENS equipment

### **Batteries**

Batteries are taken into consideration in the ARC tariff for a sales unit. Loose batteries must be settled directly with Inobat.

### **Fitness equipment**

Fitness equipment ≥ 5 kilograms has an ARC of CHF 0.56 (100100) as a general rule.

### **Safes and gun cabinets**

Up to a total weight of 25 kilograms they need to be declared. Starting at 25 kilograms, the entire disposal costs must be paid by the person disposing of the goods.

### **Shower toilets and WC terminals, beds, tables and massage chairs**

The motor must be declared.

### **Light electric vehicles with energy storage**

Light electric vehicles with energy storage (e.g. e-bikes, Segways or similar) must be registered directly with Inobat. Please note: Register e-bikes in category 88100 at Inobat. Inobat coordinates the payment of ARCs and ADFs directly with SENS.

### **Lamps with batteries**

Battery-powered lamps and lighting equipment are reported under 70050x etc.

### **Lights with additional function**

Luminaires with additional functions such as motion detectors or fire detectors are charged by weight under category 100090. If this luminaire is supplied with a replaceable light source, this does not have to be reported.

### **Excluded are**

Generators that run on petrol or diesel are excluded from the ARC

Loose cables and adapters are excluded from the ARC

Shoes and clothes with lights and batteries do not have to be registered with SENS.

e.g. appliances for ironing, sewing, cutting, pressing, mixing, chopping, kneading, baking, as well as thermoelectric wine coolers and coolers without compressor, fragrance plug, **all types of food processors, vacuum sealers**

### **Articles of animal supplies**

e.g. grooming accessories, feeders, clippers, toys, aquarium and terrarium accessories, access flaps, electric fence chargers

### **Building technology**

e.g. radiators, direct-air heaters, thermal storage heaters, heat wave lamps, hot-air ventilators, electric fireplaces, convectors, generators, compressors, electric water boilers up to 25 kg, digital room and radiator thermostat, ventilation, filtering and air-conditioning equipment, fuse boxes with all fuses, charging stations for electric cars (mobile and fixed stations), wall box chargers for electric cars, payment stations for household appliances

### **Hoisting, towing, pumping, weighing and load-transporting equipment**

e.g. winches, hoisting gear, laser spirit levels, water pumps, transport rollers

### **Devices with electric locking device for safe storage**

e.g. safes, cassettes, gun safes

---

### **Barbecues (no charcoal barbecues)**

e.g. garden barbecues, table-top barbecues, raclette and pizza ovens, electric barbecues

### **Coffee machines**

e.g. espresso makers, filter machines, fully automated systems

---

### **Miscellaneous small devices**

e.g. weather stations, thermometers, wall and table clocks, alarm clocks, animal deterrent and insect abatement systems, ground moisture sensor equipment, **lint shavers**

### **Cooking and baking equipment**

e.g. ovens, extractor hoods, vents, air-recirculating systems, cookers, steamers, grills

---

### **Medical devices, body analysis devices**

e.g. blood pressure measuring devices, bathroom scales, thermometers, pain therapy devices, cycle measuring devices, alcohol tester, blood sugar meters

### **Body care, haircare, nail care and hygiene equipment**

e.g. hairdryers, tanning equipment, shavers, sauna equipment, curlers, light curing devices for nails, manicure and pedicure items, massage devices, trimmers, epilators, waxing devices, disinfection dispenser with sensor, hand dryers

---

### **Sports, leisure and fitness equipment and fitness equipment**

e.g. heart-rate monitors, wristwatches, GPS equipment, distance meters, fit systems, avalanche search equipment, shoe heaters, child seats that play music, e-cigarettes, functional drones (not assembly kits), Multiplex FunJet, whirlpools and shower toilets (motor and control only), infrared cabins, heating blankets, alarm boxes for motorbikes and bicycles, massage chair and bed motors, all types of controls, golf accessories, rifle scope with battery

Fitness equipment  $\geq 5$  kilograms has an ARC of CHF 0.56 (100100) as a general rule.

### **Vacuum cleaners and floor-cleaning equipment**

e.g. multifunctional vacuum cleaners, manually operated sweepers, wet-and-dry vacuum cleaners, cleaning machines with and without batteries

### **Washing, drying and steam treatment**

e.g. washing machines, tumble dryers, spin dryers, fully automatic washing machines

### Regulations for refrigerator display cabinets and free standing refrigeration cabinets

- Refrigerator display cabinets are definitely excluded from the ARC financing solution and disposal of these appliances is always subject to a charge.
- Not all free standing refrigeration cabinets can be charged via the ARC. The following criteria will be applied:  
Very large appliances are excluded: total mass (length + width+ height) ≥ 4.2 m.

For the ARC, the distinction between removable and non-removable (or integrated) illuminants is relevant.

- In the case of removable illuminants, the **light** and the **illuminant** are considered separately and subject to a separate ARC.
- **Light CHF 0.18 excl. VAT and illuminant CHF 0.16 excl. VAT.**
- In the case of non-removable illuminants, the light is subject to a single ARC of CHF 0.18 excl. VAT.

#### Lights

e.g. pendant lights, drop lights, ceiling lights, recessed ceiling lights, downlights, wall lights, floor lamps, table lamps, furniture lights, industrial or business lighting, outdoor lights, backlit panels and illuminated signs, Christmas lights, rope lights with plug, light curtains, lighted figurines, bedside lamps, fairy lights with plug

The product list is not exhaustive.

- Lights with additional functions, such as motion detectors or fans, must be reported in the SENS appliance category.
- Light switches are reported in the SENS appliance category.  
Removable elements such as mounting rails, power rails, suspension structures, secondary reflectors and candelabras are not constituent parts of lights.

#### Definition Light with or without battery

A light is an inseparable device that serves exclusively to hold the illuminant or that can form a functional unit in combination with a permanently integrated, non-replaceable illuminant and, if need be, an associated control unit.

e.g. emergency lights, garden lights, light bands, night lights, battery lights, bedside lamps, Christmas tree candles, bicycle lights, lanterns, LED spots that change colour with remote control, cabinet lighting with battery, LED strips, under-cabinet lights, switch lights, strip lights, tent lights, mirrors with light, etc.

### Illuminant (light bulbs)

e.g. LED (light emitting diode) – lamps, discharge lamps, metal halide lamps, induction lamps, compact fluorescent lamps (energy-saving lamps), fluorescent lamps, fluorescent tubes, sodium vapour lamps, mercury vapour lamps

### Definition of Illuminant (light bulbs)

Illuminants are used for the production of light, are interchangeable and always form a light source.



### ARC for light conversions

- When a light is converted to LED, the new illuminant is only subject to an ARC if it can be replaced without outside assistance (i.e. by the consumer).
  - The ARC is CHF 0.16 per illuminant
  - The disposal of the old illuminant is financed
- If the conversion needs to be performed by a specialist, the new illuminant is not subject to an ARC
  - The disposal of the old illuminant is financed
  - The disposal of the light incl./excl. LED illuminant is financed

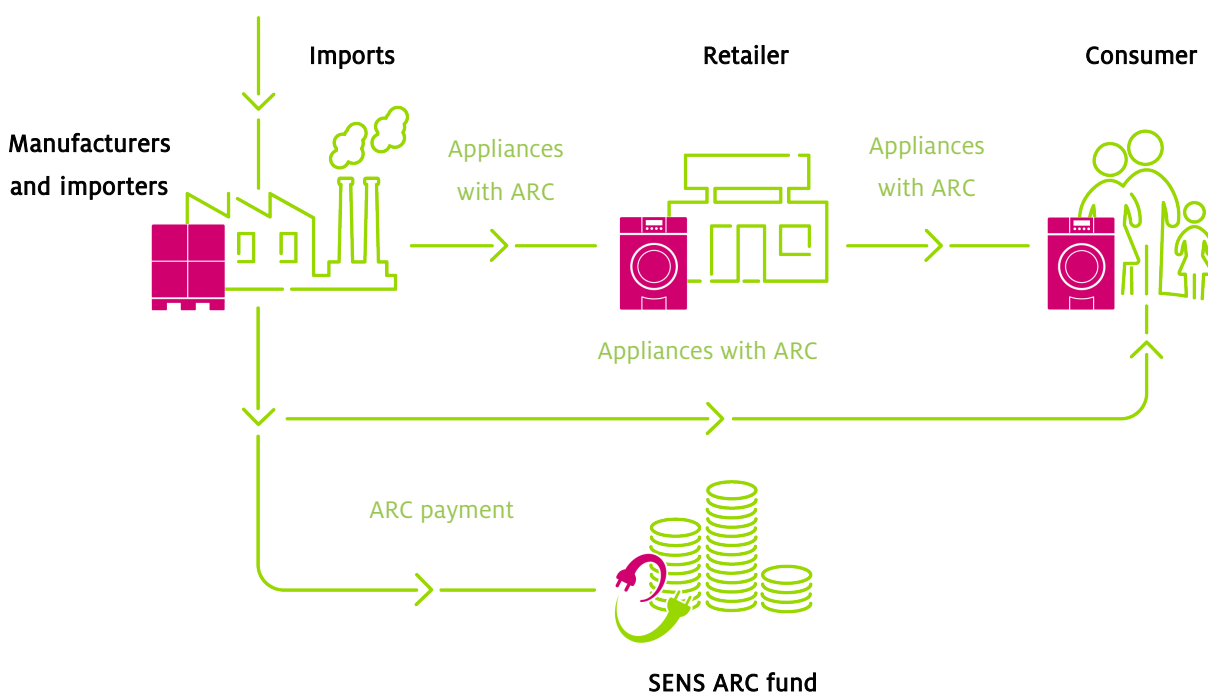

## 14. Declaration obligation

In principle, the producer or importer pays the ARC to SENS as the initial distributor. Any delegation of the declaration obligation is only possible in exceptional cases (e.g. own brands). The prior approval of SENS is mandatory and only valid with their permission. The respective form from SENS must be signed by both partners. Any cases of double reporting will result in an unscheduled inspection.



The declaration is always due in the following month.

Example: vRG declaration for the period from 01.01.2023 to 30.06.2023.

You enter the declaration in the following month "July".



## 15. Pricing transparency for the ARC

The manufacturers and importers calculate the ARC according to the above tariff categories; the fee is transferred to the retailer.

The retailer passes the ARC on to its customers.
